

Mr Christopher Pleister

Before being appointed to the Appeal Panel, Mr Pleister was a member of the Bundesanstalt für Finanzmarktstabilisierung (German resolution authority) since 2009. He chaired the institution between 2011 and 2014. Mr. Pleister is an economist and holds a doctor's degree. In 2000 Mr Pleister was appointed President of the German Bundesverband der Deutschen Volksbanken und Raiffeisenbanken until 2008. Other positions held in the private sector include being a member of the executive board of the Deutsche Genossenschaftsbank (now DZ Bank) from 1990 until 1999.

Mr Kaarlo Jännäri

Before being appointed to the Appeal Panel, Mr Jännäri held different positions at the Bank of Finland from 1973 to 1996 and was the Head of Financial Markets Department of the Bank of Finland 1996 before being nominated to be the Director General of the Financial Supervisory Authority. Mr Jännäri holds a master degree in economics. Other public positions include working for the IMF from 1980 to 1982 and being a Member and Vice Chairman of the Committee of European Securities Regulators from 2000 until 2007

Mr Marco Lamandini

Mr Lamandini is professor of company and financial law at the University of Bologna. Mr Lamandini also is an attorney-at-law admitted to the Italian Bar. He sat in the Legislative Commission set up by the Italian Ministry of Justice to modernise bankruptcy proceedings and assisted the Bank of Italy in the implementation of the BRRD into national law. Other public positions include being a component of the Board of Appeal of the European Supervisory Authorities and being a member of the Company Law Expert Group appointed by the European Commission.

Ms Eleni Dendrinou

Ms Dendrinou-Louri is a professor of economics at Athens University of Economics and Business and was recently teaching as a visiting professor at the London School of Economics. As deputy governor at the Bank of Greece from 2008 to 2014, Ms Dendrinou-Louri was responsible for Monetary Policy and Bank Resolution. Other educational engagements include visiting fellowship for a series of lectures at US universities and board memberships in the Hellenic Foundation for European and Foreign Policy (ELIAMEP) and the Foundation for Economic and Industrial Research (IOBE).

Mr Luís Domingos Silva Morais

Mr Silva Morais is an attorney at law and an associate professor of Law at the Lisbon Law University (Jean Monnet Chair in EU Economic Regulation). Mr Silva Morais is the founder and Chairman of the Research Centre on Regulation and Supervision of the Financial Sector and Vice-President of the Institute for University Cooperation. Other public positions include being an executive director of the Portuguese Supervisory Authority of Insurance and Pension Funds from 1998 until 2001 and Chief of Cabinet of the Secretary of State of Treasury and Finance (Portuguese XIII Constitutional Government – 1996-98).

Mr Herbert Pichler

Mr Herbert Pichler was the Managing Director of the Department Banks and Insurance Companies of the Austrian Federal Economic Chamber from 1986-2012 and was Supervisory Board Member at the Austrian Financial Market Authority from 2002-2012. From 2004-2010 he was member of the Consultative Panel of CEBS in London. After 2012, he became Senior Advisor to the Austrian Minister of Finance regarding financial market stability including nationalized banks. Beside other public positions, he was a Lecturer at the Vienna University of Economics and Business holding seminars on current developments in banking regulation.

Mr David Ramos Muñoz

Mr David Ramos Muñoz is Professor of Commercial Law at Universidad Carlos III de Madrid, and the University of Bologna. He majored in Law and Business Administration and obtained a PhD at University of Bologna. He has acted or acts as an expert in applied research projects for the European Parliament and the European Commission, and in investment arbitration proceedings. He is a lawyer at the Madrid Bar, consultant on cross-border issues for private sector entities, and arbitrator at the Madrid Arbitration Court.
